## Rules and Regulations

1. The following rules will be interpreted solely by the officials and their decisions will be final.
2. **Eligibility:** All contestants 16 yrs. and older who have paid entry fees are eligible. Anyone under 16 yrs. must be accompanied by parent or guardian. This is a two man contest but you can fish alone, if total entry is paid.
3. **Boats and motors:** All boats 14 ft. and longer with a minimum of 25 hp will be allowed. All boats in bass tournament must be equipped with a working aeration system. Kill switches are recommended to be used. No boats may be trailered during tournament hours. Live wells will be checked before entering the water.
4. **Life jackets:** Life jackets must be worn when boat is on plane. All coast guard rules for the lake will be in effect. **Be sure your equipment is updated.**
5. **Fishing Location:** Anywhere on the lake where permitted by the corp of engineers is permitted. No Fishing allowed around Marina docks and boat slips, as posted on docks. Some areas are closed and not accessible. Be aware of these, you can be fined if trespassing.
6. **Courtesy rule:** As courtesy you will need to stay 50 feet away from another contestant's boat. Unless contestant at location first grants you permission to be closer. (Be courteous to others fishing in tournament or not in tournament, try to avoid cutting off other anglers.)
7. **All entry fees are non-refundable.**
8. **Weigh In/Limits:** **Bass:** Large mouth & smallmouth bass only over 18" will be weighed unless your team has bass pass. If your team has bass pass then you can weigh up to 2 fish in between 15" to 18" in length. There is a 5 fish limit per boat. Short fish will not be weighed and will cause a 1 lb. deduction from your total weight. Dead fish will have a 1 lb. deduction off your weight. Any frozen, iced, or mangled fish will result in disqualification. **Crappie:** Crappie only 10" or longer will be weighed. Short fish will not be weighed and cause a 1 lb. deduction from your weight. Dead fish will not result in a penalty. There is a 10 fish limit per boat. Any frozen, iced, or mangled fish will result in disqualification. **There will be a late penalty of 1 lb. every 5 minutes that will be deducted for crappie and bass.**
9. **Equipment:** **Bass:** Rods and reels with artificial baits only are allowed. Pork style baits are acceptable. Dip nets are allowed to assist in landing fish. **Crappie:** Fish must be caught with rods and reel and dip nets may be used to assist in landing fish. Live or artificial baits are allowed.
10. **Ties will be broken by teams largest single fish and then order of sign in.**
11. **Big fish:** Only 1 fish per team will be weighed for big fish.
12. **Protests:** Must be presented, in writing, to the tournament director prior to the conclusion of weigh in, or it will not be considered.
13. **Cancellations:** Tournaments can be canceled due to weather conditions. But they will be canceled on very rare occasions. **(We will fish rain or shine, wind or no wind. Fish at your own risk.)**
14. A team consists of no more than 2 contestants.
15. Tournament officials will measure any fish that are questionable in length.
16. Only tournament officials will be allowed to measure fish.
